Thank you for visiting this site. We*

*agree with you that people have the right to make choices about who will be their family advocate. We are not telling you not to use the people listed on this site. We provide the information we know about people so you can make a fully informed choice. You have every right to ignore this Consumer Advisory.*

*But, consider this. Statistically, CPS returns 50 % of the children they seize in 6-12 months without the participation of a family advocate. The other 50% go to Termination of Parental Rights (TPR). If*

*your advocate did not get your children back before 6 months, what's the point of having a family advocate?*

*Family advocates trained and certified by Family Rights Advocacy Institute get children returned home in days or weeks, not months. Or they help prevent the removal of the children completely. They assist to prevent an adjudication and have even helped parents win TPR hearings.*

*But if you don't want those kinds of result, by all means, don't use a trained and certified family advocate.*
