## Boat Slip Lease Agreement

This boat slip lease agreement between Gulfport Yacht Club (“GYC”) and

\_\_\_\_\_, Member of the GYC (“Member”).

Member hereby rents a slip from the GYC subject to the terms and conditions set forth herein.

Member understands and agrees that the slip rental is subject to the Club Rules of the Gulfport Yacht Club, including Article XIX (“Docks and Piers”). Such rules are incorporated herein by reference. Member acknowledges receipt of a copy of said rules, and agrees to abide and be bound by the same. The GYC reserves the right to amend said rules from time to time, and Member agrees to be bound by any such amendments. Said rules, as from time to time amended, are referred to herein as the “Club Rules”.

Without limiting the general application of the Club Rules, certain of said rules are set forth below:

XIX.f.(2): A Member agrees to assume responsibility for any damage caused by his boat, himself, or his guests while utilizing the Gulfport Yacht Club piers, slips, and associated facilities.

XIX.f.(5): Adequate evidence of protection and indemnity liability, with limits meeting the Governing Board’s approval, will be furnished prior to slip assignment.

No failure on the part of the GYC to exercise any power, right, privilege, or remedy under this agreement or the Club Rules or to require strict performance thereof, and no delay on the part of the GYC in exercising any power, right, privilege, or remedy under this agreement or the Club Rules or in enforcing such rules, shall operate as a waiver of such power, right, privilege, or remedy or right to enforce such rules.
