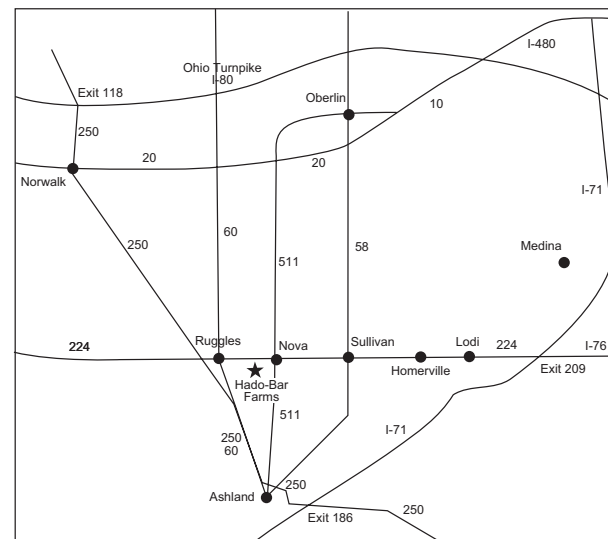
Directions to the Trial Site

From the West,

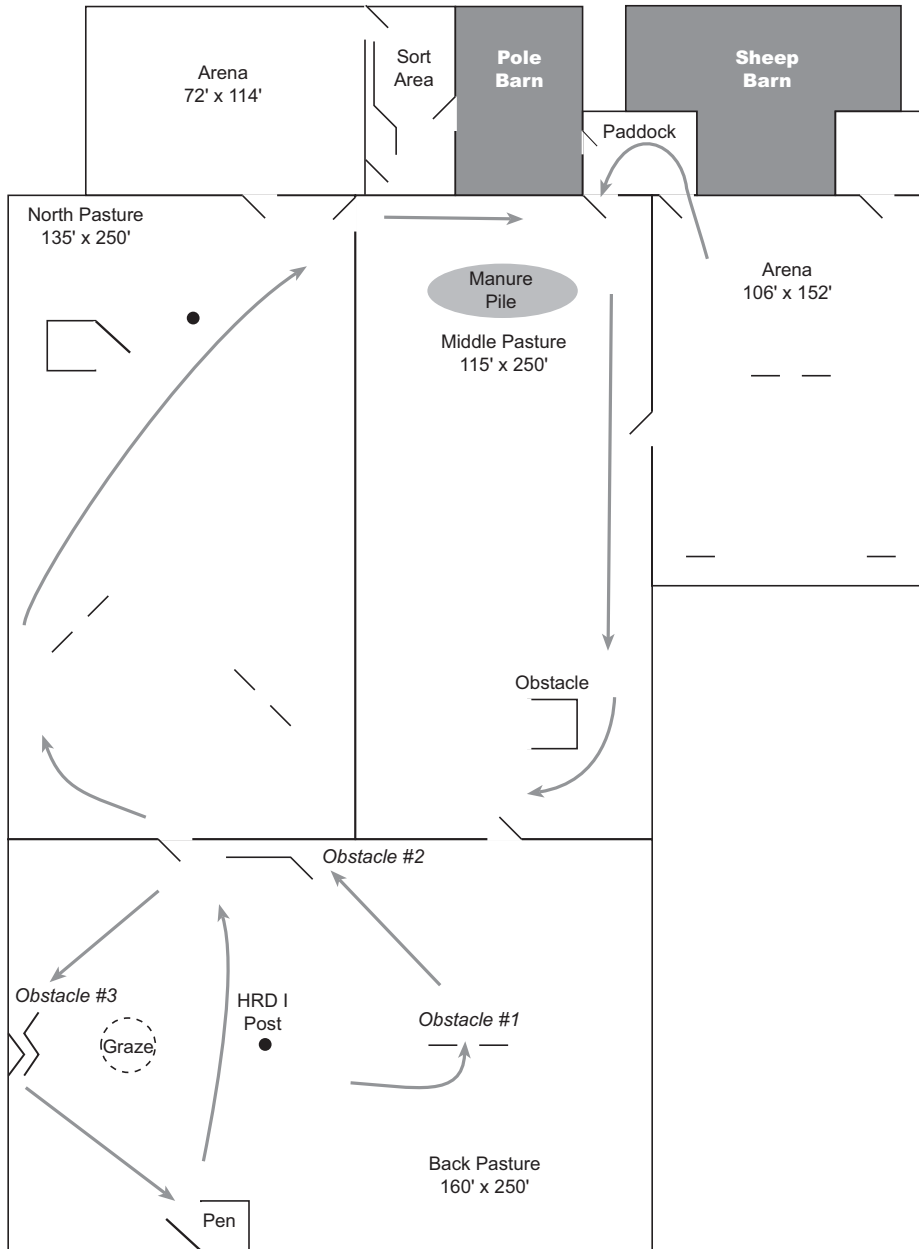

HRD I

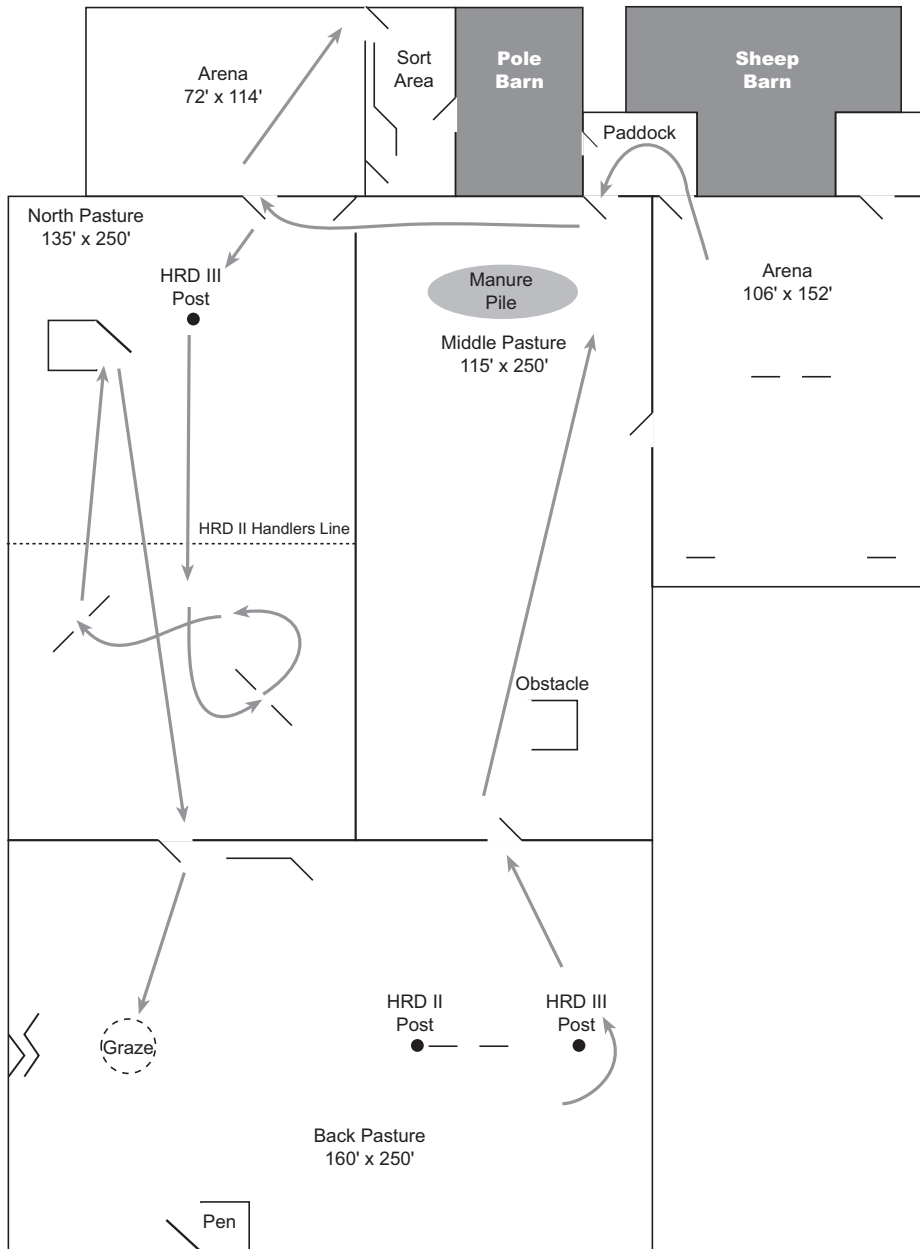
(Time Allowed: 20 minutes)

1. Gather 10 sheep from Arena. Dog need not hold sheep away from gate while handler opens gate to Paddock. Once sheep are in Paddock handler will close gate to Arena.

Handler and dog move through Paddock and into Middle Pasture. Handler may re-enter Paddock with dog to assist dog in removing the 10 sheep from Paddock. Handler will then sort 5 sheep back into Paddock. **(10 Points)**
2. Handler will move 5 sheep down fenceline of Middle Pasture, clockwise around Obstacle to Back Pasture Gate. Dog must hold sheep away from gate while handler opens gate. Once sheep are in Back Pasture, handler will close gate. **(10 Points)**
3. Handler and dog will move sheep to Graze Area. Once sheep are at Graze Area, Handler will recall dog and position dog next to HRD I post. Handler may move within 15 feet of sheep.

Handler will send dog on outrun, lift and fetch. When sheep reach handler, handler may move with sheep to Obstacle #1 (Center Panels). **(10 Points)**
4. Dog will put sheep through Obstacle 1 (panels). Handler will not lead sheep through Obstacle. Once sheep have cleared Panel Obstacle, they will be moved to the opening of the Obstacle #2 (Y-Chute). Handler may move with sheep to opening of Obstacle #2. **(10 Points)**
5. Dog will put sheep through Chute. Handler will not lead sheep through Chute. When sheep have exited Chute, they will be moved to the opening of Obstacle #3 (Z-Chute). **(10 Points)**
6. Dog will put sheep through Chute. Handler will not lead sheep through Chute. When sheep have exited Chute, they will be moved to the Pen. **(10 Points)**
7. Handler and dog will pen sheep (handler may not enter pen and at least one head MUST be penned). After the sheep are penned, a signal will be given from the judge, and the sheep are removed from pen. **(10 Points)**
8. Handler will move sheep to North Pasture gate. Once sheep are in North Pasture, handler will close gate. **(5 Points)**
9. Handler will move sheep, around north set of panels, to Middle Pasture Gate. Dog must hold sheep away from gate while handler opens gate. Once sheep are in Middle Pasture, handler will close gate. **(10 Points)**
10. Handler will move sheep to Paddock. At Paddock, dog must hold sheep away from gate while handler opens gate to Paddock. Handler will close gate when sheep have entered Paddock. **(5 Points)**

HRD II

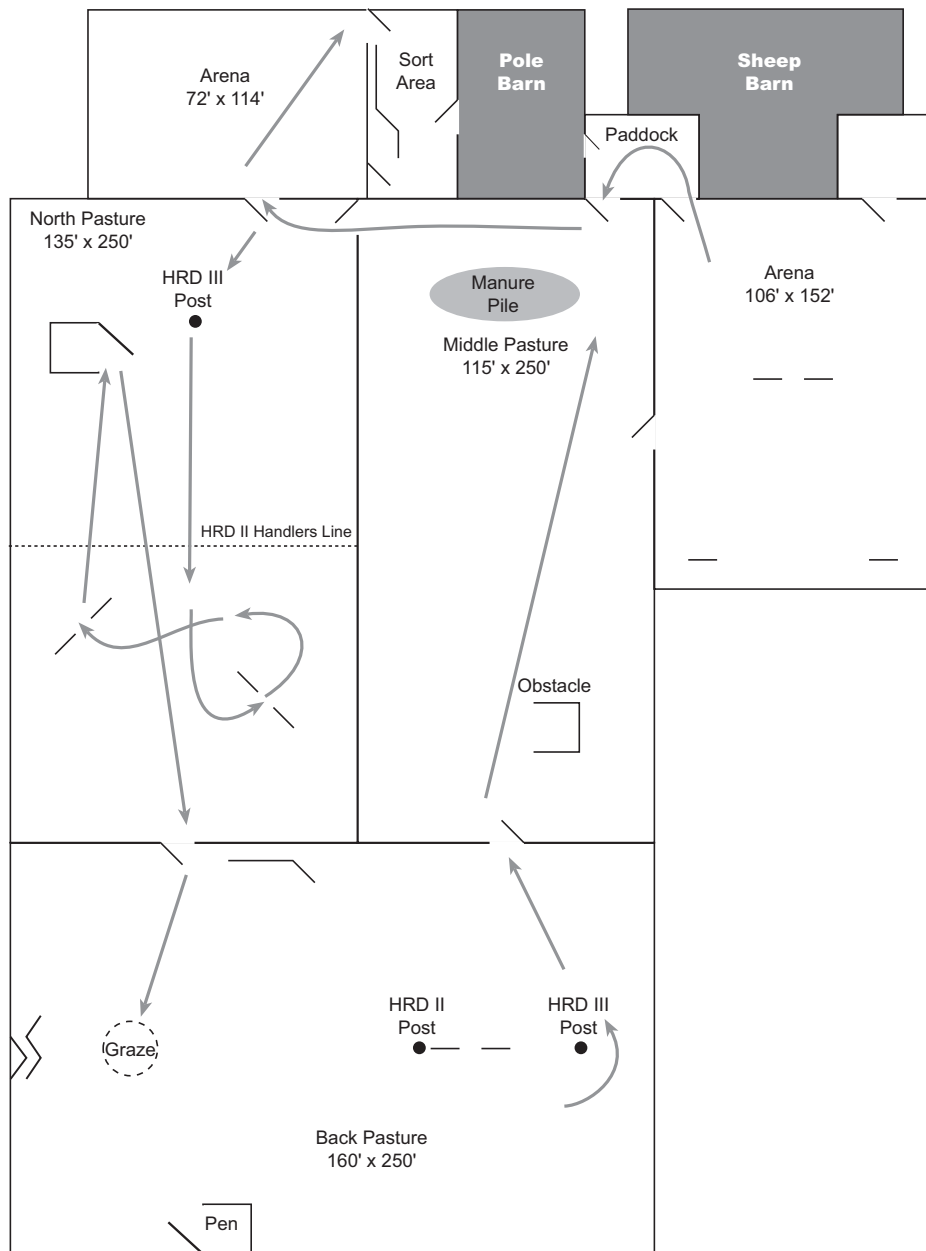
(Time Allowed: 25 minutes)

1. Gather 10 sheep from Test Arena. Once sheep are in Paddock handler will close gate to Test Arena.

Handler and dog move through Paddock and into Middle Pasture. Handler will send dog back into Paddock and move all sheep to Middle Pasture. Handler will close gate to Paddock and proceed to move the sheep to North Pasture. Dog need not hold sheep away from gate while handler opens gate to North Pasture. **(10 Points)**
2. Once sheep are in North Pasture, handler will close gate and move sheep to Duck Arena Gate. Once sheep are in Arena, handler will close gate.

Handler will move sheep to Sort Area gate. Dog need not hold sheep away from gate while handler opens gate to Sort Area. Once sheep are in Sort Area, handler will close gate. **(10 Points)**
3. Handler and dog will move sheep into sorting race. Handler will use sorting race to sort 5 ANY sheep into Arena. After the sort has finished, the remaining 5 sheep will be moved into the Pole Barn. **(10 Points)**
4. Gather the 5 sheep and move them to the North Pasture. Once sheep are in North Pasture handler will close gate. **(5 Points)**
5. Handler will move sheep to HRD II line and dog will then drive sheep down middle of the arena to left set of panels. Dog will put sheep through the panels and then drive them counter-clockwise to the second set of panels. Dog will put sheep through second set of panels. Handler will stay behind HRD II line. **(20 Points)**
6. Once the sheep have cleared the second set of panels, the handler may move to Free Standing Pen to assist dog in penning sheep (at least one head MUST be penned). When sheep have been penned, handler will close gate. After gate is closed, handler will open gate and then remove sheep. **(10 Points)**
7. Once sheep are out of Free Standing Pen, handler will close pen and move sheep to Back Pasture gate. When sheep have entered Back Pasture, handler will close Back Pasture gate. **(5 Points)**
8. Handler will move sheep to Graze Area if needed. Handler will recall dog and position dog next to HRD III post. Handler may move to the HRD II post. Handler will send dog on outrun, lift and fetch. When sheep reach handler at HRD II post, handler may move with sheep to HRD III Post. Dog will take sheep counter-clockwise around marker. Handler must not lead sheep around marker. **(10 Points)**
9. Handler will move sheep to Middle Pasture Gate. Dog must hold sheep away from gate while handler opens gate. Once sheep are in Middle Pasture handler will close gate. **(5 Points)**
10. Sheep will be moved to Paddock where dog must hold sheep away from gate while handler opens gate to Paddock. Handler will close gate when sheep have entered Paddock. **(5 Points)**

HRD II & III Course Layout

If a tie still exists, the score of the sort will be used to break the tie.

HRD III

(Time Allowed: 30 minutes)

1. Gather 15 sheep from Test Arena. Once sheep are in Paddock handler will close gate to Test Arena.

Handler and dog move through Paddock and into Middle Pasture. Handler will send dog back into Paddock and move all sheep to Middle Pasture. Handler will close gate to Paddock and proceed to move the sheep to North Pasture. Dog need not hold sheep away from gate while handler opens gate to North Pasture. **(10 Points)**
2. Once sheep are in North Pasture, handler will close gate and move sheep to Duck Arena Gate. Once sheep are in Arena, handler will close gate.

Handler will move sheep to Sort Area gate. Dog need not hold sheep away from gate while handler opens gate to Sort Area. Once sheep are in Sort Area, handler will close gate. **(10 Points)**
3. Handler and dog will move sheep into sorting race. Handler will use sorting race to sort 5 **MARKED** sheep into Arena. After the sort has finished, the remaining 10 sheep will be moved into the Pole Barn. **(20 Points)**
4. Gather the 5 sheep and move them to the North Pasture. Once sheep are in North Pasture handler will close gate. **(5 Points)**
5. Handler will move sheep to HRD III post and dog will then drive sheep down middle of the arena to left set of panels. Dog will put sheep through the panels and then drive them counter-clockwise to the second set of panels. Dog will put sheep through second set of panels. Handler will stay at HRD III post. **(20 Points)**
6. Once the sheep have cleared the second set of panels, the handler may move to Free Standing Pen to assist dog in penning sheep (at least one head **MUST** be penned). When sheep have been penned, handler will close gate. After gate is closed, handler will open gate and then remove sheep. **(10 Points)**
7. Once sheep are out of Free Standing Pen, handler will close pen and move sheep to Back Pasture gate. When sheep have entered Back Pasture, handler will close Back Pasture gate. **(5 Points)**
8. Handler will move sheep to Graze Area if needed. Handler will recall dog and position dog next to HRD III post. Handler will stay at HRD III post. Handler will send dog on outrun, lift and fetch. When sheep reach handler at HRD III, dog will take sheep counter-clockwise around marker. Handler must not lead sheep around marker. **(10 Points)**
9. Handler will move sheep to Middle Pasture Gate. Dog must hold sheep away from gate while handler opens gate. Once sheep are in Middle Pasture handler will close gate. **(5 Points)**
10. Sheep will be moved to Paddock where dog must hold sheep away from gate while handler opens gate to Paddock. Handler will close gate when sheep have entered Paddock. **(5 Points)**
