**GOVERNMENT OF ANDHRA PRADESH  
AGREEMENT BETWEEN THE GOVERNMENT AND JOINT ACTION  
COMMITTEE OF EMPLOYEES, TEACHERS, WORKERS AND  
PENSIONERS ANDHRA PRADESH**

In pursuance of the detailed deliberations between the Government and the Chairman and members of Joint Action Committee of Employees, Teachers Workers and Pensioners, the following was agreed to on 23.01.2011:-


- i. The existing rate of House Rent Allowance of 10% to be enhanced to 12% and the rate of House Rent Allowance from 12.5% to be enhanced to 14.5% with effect from 1<sup>st</sup> April, 2011.
- ii. The existing Automatic Advancement Scheme of 8/16/24 years is to be modified as 6/12/18/24 years with effect from 1.2.2010
- iii. Health Cards: Rajiv Arogyasri Trust will operate the scheme formulated by the HM&FW Department with the modification that the representatives of employees who are permanent members in the Joint Staff Council (State Level) will be co-opted here. A separate Trust will be formed within six months. The Scheme will be reviewed after two years.
- iv. Two notional increments will be sanctioned to the untrained teachers belonging to SC, ST and BC categories and Special Vidya Volunteers for the period of untrained service on the date of entry into regular time scale.
- v. Existing ceiling on DCRG is to be enhanced from Rs.7.00 lakhs to Rs.8.00 lakhs with effect from 1.4.2011.
- vi. Medical Invalidation Scheme for 1198 Panchayat Secretaries working on contract basis would be worked out within one month as per Court Orders.
- vii. The issue of regularization of 1500 Full Time Contingent employees working in Sericulture Department will be considered as per Rules.
- viii. The issue of house sites will be considered after final outcome of the case pending in Hon'ble Supreme Court. The lands already alienated in favor of employees' housing societies and also those earmarked for alienation would not be allotted or alienated to others.
- ix. Filling up vacant posts (Class-IV/Junior Assistant / Typist / Drivers) will be considered according to Government needs.

- x. All the recommendations of the Ninth Pay Revision Commission including abolition of apprenticeship to teachers will be considered and orders will be issued accordingly.
- xi. Special Leave as recommended by Civil Surgeon up to a maximum of 45 days will be sanctioned for women employees who undergo hysterectomy operation.

The Joint Action Committee of Employees, Teachers and Workers has agreed to drop all further agitation programmes and co-operate with the Government to carry out all the development programmes of the Government.
