**Table Tennis Report**

**USA Table Tennis:**

USA Table Tennis is the National Governing Body for Para Table Tennis. Their functions are: Developing selection criteria for USOC approval for Para PanAm and Paralympic Games; selection of athletes for Para PanAm and Paralympic Games; selection for World Championships are made by the ITTF Para Division and verified by the USA Table Tennis; selection of head coach and assistant coaches for international trips; process entry forms for ITT-PTT sanctioned events; organize and coordinate national classification system; select National Para and Junior Team Members; conduct three disabled events (wheelchair, standing and intellectually disabled) at the USATT National Championships and US Open, and conduct international Paralympic Table Tennis competition. The USATT is responsible for the training for and development and conduct of International classification for Paralympic athletes for all 11 classification divisions for Paralympic Table Tennis in the United States. **International Competition:**

**London 2012 Paralympics**

Three athletes, Tara Profitt – CT, Pam Fontaine – TX, and Tahl Lebovitz – NY, two coaches: Sean O’Neill – Head Coach, Keith Evans – Asst. Coach and one Escort: Matt Profitt represented the USA at the London Games. London did a fantastic job in conducting the Paralympic Games. There were spectators at all of their events. I attended as a Journalist working with Sebastian Defrancesco’s company Four Wheel Media.

Mike Dempsey International Memorial Tournament, Nov. 27-Dec. 2, 2012, San Diego, CA  
Twenty-five countries with a total of 150 athletes Classes 1-11 have entered the MDMTT tournament in San Diego. Prior to the tournament there will be an adult and junior training camp from Nov. 24 to 27. The USA Table Tennis is accepting entries for the MDMTT tournament and the juniors training camp. Andre Scott at [mdmtt1@gmail.com](mailto:mdmtt1@gmail.com) is accepting entries for the adult training camp and he can also answer questions on the tournament. In addition to competition and training for players, an International Classification seminar is being held there.

**National and Regional Competitions**

Our National competition is held every December at the USATT National Championships, which will be held this year in Las Vegas from Dec. 18-22 for Classes 1-11. This is the first time we will include Class11 for Paralympic qualified Intellectually Disabled athletes in our National Championships. There are table tennis competitions at the Regional competition sanctioned by WASUSA. Juniors and beginners usually participate at these events, which is always a good place to start. We encourage the regions to continue to include table tennis in their regional competitions.



**Juniors:**

The Table Tennis tables donated by STC to the junior program were finally delivered this year. Score cards were also donated to NJDC.

**Classification:**

Sharon Frant Brooks is the USATT National Classification Officer for Paralympic Table Tennis. Sharon is working on creating a system under the USATT to train regional and national table tennis classifiers. Any athlete that is seen by Sharon or a will be given a national classification card. We are recommending that anyone who wants to compete in international table tennis to be first classified by Sharon. Classifications are generally conducted 3-4 times a year at the Eastern Open Championship in May of each year at Rutgers University in New Jersey and the US National Championships in December in Las Vegas, the US Open Championships and if possible, a site to accommodate geographical needs of athletes to be classified.

Sharon will be hosting a Classification Seminar in San Diego, November 24-27 for Classes 1-11. 6 USA classifiers will be attending and will become the only recognized National Paralympic Table Tennis classifiers in the country, and will begin the process of training local and regional classifiers for all 11 classes of Paralympic table tennis.

I am happy to say that WASUS board of directors approved \$1,000.00 from the table tennis fund to help fund two of our members and USA classifiers, Jeannie Senter, MS, PT and Jennifer Lucarevic to attend the seminar. James Beckford and Kenneth Brooks of the USA will also be attending as technical classification candidates, but were not included in the support as they are not currently members of WASUSA. 20-30 players with intellectual disabilities from 5-6 countries will be classified in San Diego and will also play in the Mike Dempsey Memorial Tournament.
